# Dual Enrollment 2020-2021

## **Dual Enrollment Application Steps:**

- 1. Review the Dual Enrollment Program FAQs sheet- see attached document.
- 2. Login to your GAfutures account: www.gafutures.org. If you do have an account, create one.
- 3. Select the "College Planning" tab once you are logged in. Go to "College Applications" and complete the admissions application(s) for all schools you are considering for Dual Enrollment courses through GA Futures. You will be redirected to the appropriate site to complete the application. Note- please select "Dual Enrollment" for admission type. This will allow you to submit the application(s) without a fee. \*Must meet minimum admissions requirements for the school(s) you are considering.

## \*Participating Colleges/Universities

- a. See attached document.
- b. Transportation is not provided. The student and their families are responsible for transportation to and from campus where courses are taken. Courses can be taken online; however, course offerings are not guaranteed.
- c. Schools have different deadlines. Please visit the website of the school(s) you are considering for additional information.

## \*Transcript(s)

 Request your transcript(s) through GAfutures for all schools that you are considering for Dual Enrollment. Transcripts will be released electronically once the request is made.

#### \*Test scores

- a. SAT scores can be sent through <a href="www.collegeboard.org">www.act.org</a>. Scores are required for admissions review.
- b. The PSAT and/or Accuplacer is accepted at some technical and two year schools. As of this year, some 4 year colleges will accept. Please verify you're your college or university of interest.
- c. There is still time to register for the June/July SAT and/or ACT. Be sure to request that your score reports are sent to the schools you are considering for Dual Enrollment at the time of registration.
- 4. Complete the 2020-2021 funding application for all schools you are considering for dual enrollment. Multiple schools can be selected within the application. Your GAfutures account profile will prepopulate the funding application. Be sure your GAfutures account profile has your correct information (legal name, email address, home address, social security number and Date of Birth). If you do not have a valid social security number, when creating a GAfutures account profile, you will be assigned a temporary ID.

## \*Required Parent Participation Agreement for all students

- a. Option 1 for completing the Parent Participation Agreement: Must include parent's email. A Parent Participation Agreement will be emailed to the parent, and the parent must submit the form electronically.
- b. Option 2 for completing the Parent Participation Agreement: Parent/guardian may visit Parent/Guardian Participation Agreement to electronically sign the agreement.
- c. Option 3 for completing the Parent Participation Agreement: If the parent/guardian cannot access the electronic agreement, they should print, complete and sign the Parent/Guardian Participation Agreement and provide it to the student's high school advisor/counselor.

Once completed, the application is valid for the academic year unless you change high schools.

5. Once accepted to a College/University, you will be required to communicate with the school counselor to complete the SPA- Student Participation Agreement to select Dual Enrollment courses.

## \*Required Student Participation Agreement for all students

a. The Student Participation Agreement and funding application **must** be approved by the school counselor. Note- this will be done after your admission application(s) and funding application(s) have been submitted and you've been accepted.
